It was resolved that a comment should be sent to LCC indicating that this Council had concerns that the approach to the Lea Road access point designed for buses, pedestrians and cyclists was not suitable since there are narrow footpaths in places and there is no cycle lane. It is therefore suggested that the proposals should include suitable improvements to Lea Road to take account of the current deficiencies.

To consider planning application PCC 06/2022/1110 for siting of up to 16 lodges for occupation by children in care at former Sand Extraction Area, Wallend Road, Preston

It was resolved that no representation should be made.

To consider a verbal request from Cottam Primary School to allow our lengthsman team to undertake some basic maintenance work to their outside play area which will involve weed removal, removal of damaged play equipment and repair/painting of other wooden play equipment and access doors to school. This work is expected to take up to two days and will involve labour only with no financial contribution.
