**1. Disclosable Pecuniary Interests**

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the **relevant person** has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

*(A **relevant person** is you, your spouse or civil partners, a person with whom you are living as husband and wife, or a person with whom you are living as if you were civil partners)*
