

Section 30 of the Localism Act 2011 and The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Notification by Member of LEA & COTTAM PARISH COUNCIL of Disclosable Pecuniary Interests/Personal Interests

I, Chris Smith

An Elected/co-opted Member of Lea and Cottam Parish Council.

GIVE NOTICE that I have the following Disclosable Pecuniary Interests and Personal Interests (*please state 'None' where appropriate*):

1. Disclosable Pecuniary Interests

Employment, office, trade, profession or vocation

Any employment, office, trade, profession or vocation carried on for profit or gain.

University of Central Lancashire

Sponsorship

Any payment or provision of any other financial benefit (other than from the Council) made or provided within the period of 12 months ending with the day on which you gave notice under Section 30(1) or Section 31(7) of the Localism Act 2011 in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Contracts

Any contract which is made between the **relevant person** (or a body in which the relevant person has a beneficial interest) and the relevant authority –

- (a) under which goods or services are to be provided or works are to be executed; and
- (b) which has not been fully discharged.

(A **relevant person** is you, your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you were civil partners)

Land

Any beneficial interest in land which is within the area of the parish of Lea and Cottam including the address at which you reside if owned or any property you own and rent out to others.

Licences

Any licence (alone or jointly with others) to occupy land in the parish of Lea and Cottam for a month or longer. (e.g. grazing livestock)

Corporate tenancies

Any tenancy where (to your knowledge) –

(a) the landlord is the Council; and

(b) the tenant is a body in which the **relevant person** has a beneficial interest. (applies to your partner)

(A **relevant person** is you, your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you were civil partners)

For example, you and/or partner is a partner or a Director in the tenant company or has securities in the tenant company.

Securities

Any beneficial interest in securities (shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme and other securities of any description, other than money deposited with a building society) of a body where –

(a) that body (to your knowledge) has a place of business or land in the parish of Lea and Cottam and

(b) either –

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the **relevant person** has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

(A **relevant person** is you, your spouse or civil partners, a person with whom you are living as husband and wife, or a person with whom you are living as if you were civil partners)

2. Personal Interests

I am a member or in a position of general control or management of the following body/ies to which I have been appointed or nominated by the Council. (e.g. Appointed by the Council on an outside body)

I am a member or in a position of general control or management of the following body/ies exercising functions of a public nature. (e.g., School governor)

Cottam Primary School

I am a member or in a position of general control or management of the following body/ies directed to charitable purposes. (e.g., Trustee of a charity)

Cottam Community Association

I am a member or in a position of general control or management of the following body/ies one of whose principal purposes include the influence of public opinion or policy. **(This includes any political party or Trade Union).**

Details of the interests of any person from whom I have received a gift or hospitality with an estimated value of at least £25

Any easement, servitude, interest or right in or over land which does not carry with it a right for you (along or jointly holding with another) to occupy the land or to receive income.

Please note, that the law requires you to notify the Council's Monitoring Officer, within 28 days of election or appointment, of **any** disclosable pecuniary interest which you have at the date of this notification. You are required to update this notification if you are re-elected or re-appointed. It is a criminal offence, if without reasonable excuse, you fail to do this, or the notification you give contains false or misleading information or you are reckless as to whether the information is true and not misleading.
